- That all the facilities prescribed under Rules 50 & 51 of DSER, 73 shall be made available to the students. Provisions of Rules 6, 7 and 8 be strictly observed.
- That a proper library shall be established and faciliti for reading room shall be made available for students a well as teachers. Books as per the ratio of 10 books per student may be added and facilities of reading roo may also be provided immediately and more books worth Rs.5000/- be purchased by the srart of the next session and the list of books are furnished to the Education officer for verification.
- Adequate sports material shall be purchased and made available to the students immediately.
