Subj:- Upgradation of School from Middle to Secondary stage with eff
from academic session 1997-98 (without Aid).

Sir,

With reference to your application on the subject cited above I am directed to convey the approval of appropriate authority for ungradation of your school from middle to secondary level with effect from academic session 1997-98 subject to the fulfilment of the following terms and condition (without aid).

1. That the school shall abide by the provisions of Delhi school education Act, 1973 and Rules framed there under as well as the instruction issued from time to time by the department.
2. That the school shall admit students without any discrimination caste and creed.
3. That the school shall meet the additional liability of secondary classes alongwith additional class rooms for class IX and X.
4. That the School Shall purchase adequate science lab equipment and apparatus as per the norms of C.B.S.E/ Education-Department for Secondary classes.
5. That a proper library shall be established and facilities for reading-room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student shall be purchased and made available to the students.
6. That a adequate sports material shall be purchased and made avail to the students.
7. That the school shall strictly abide by the provisions of section 12 of the Delhi School Education Act/Rules 1973.
8. That the School shall not run any un-recognised class or any non-educational activities within the school premises and all the recognised classes shall be run at one place at the above address. Only Nursery classes be held from the premises of the school.

10. Fresh Health certificates from MCD be obtained and produced to Education Officer for verification.
11. The Management of the school will obtain land from DDA if not obtained, in the name of the society through Director of Education, Delhi and shall construct the school building thereon for the school as per specifications of the Deptt. within period of two years that adequate and sufficient accommodation 10 Sq. ft. per student shall be provided for the class room. no class room shall be less than 200 s.q. ft. area.
12. That proper facilities for drinking water, toilets and first aid be provided. Separate toilets for boys, girls and separate toilet for ladies and gents staff be also provided.
13. That the Managing Committee of school shall not increase/extra fees during the ensuring academic session without prior approval of the Director of Education which is mandatory requirement under sub-section (3) of section 17 of Delhi School Education Act & Rules 1973.
14. That the School Authority will apply for P.F. facilities to the provident fund commission and will provide the same to the staff in proper manner.
15. That the all facilities prescribed under rules 50 & 51 of the Delhi School Education Rules 1973 shall be made available to students.
16. That Xth class should not be added without the prior approval of the Directorate of Education.
17. That the Management of the School shall create a Reserve Fund equal to minimum three months salary of the staff in the joint name of the Directorate of Education and the Manager of the School.
18. That the school shall comply with the norms of the CBSE for affiliation & examination purposes.
19. The report about the fulfilment of the above conditions shall be sent to the Education officer within six months.
20. The School will apply for nominees of DE/Advisory board, to the Act. Branch of Directorate of Education.
21. The school should provide GPF, LTC Medical Facilities to the staff as per B.S.E.R.
